
## MATTHEWS-THOMAS PARK BOARD

## Council Meeting, March 11, 2009

[Mayor Goncy, Clerk-Treasurer Zeman, Solicitor Hesske and Councilpersons: Cheung, Foss, Hudson, Lightner, Miller and Slane were present.]

After Roll Call, the Pledge of Allegiance and Approval of previous meeting minutes and tonight's Meeting Agenda:

**ORDINANCE #3,** Approved compensation for village employees for 2009.

**RESOLUTION #4,** Established a video service provider fee for any video service provider offering video service in the village and authorizing the Mayor to give notice to said video service providers of the newly established fee.

**RESOLUTION # 9.** Authorized the Mayor to enter in to agreement with Unison Site Management for buyout of the lease on two village owned cellular towers.

**RESOLUTION #10,** Appointed Constance Hesske as Solicitor of the Village of Boston Heights for the remainder of 2009 year.

**RESOLUTION #11,** Authorized the Clerk-Treasurer to advertise for computers and software to be installed in Village of Boston Heights police cruisers.

**A MOTION**, Approved the January 2009 Village Financial Statement.

## **COMMITTEE REPORTS:**

Lightner - posted a possible upcoming vacancy for Police Chief.

Cheung - Planning Commission approved changed signs from Holiday Inn to Clarion Inn. Approved short term sell off of trucks at a Chittenden Road business. Stated the Comprehensive Plan Comm. would meet March 25.

Hesske - Crown Castle, a third village owned cell tower, proposes a lease extension.

Zeman - reported that she, the Solicitor and Mayor are meeting to learn more about the Northeast Ohio Regional Sewer District's proposal to impose a storm water utility fee on current village public sewer residents.

## Council Meeting, April 8, 2009

[Mayor Goncy, Clerk-Treasurer Zeman, Solicitor Hesske and Councilpersons: Cheung, Foss, Hudson, Miller and Slane were present.

After Roll Call, the Pledge of Allegiance, Approval of Meeting Agenda and Minutes presented and corrected if needed.

**ORDINANCE E, FIRST READING.** An ordinance to provide flood damage prevention for resident's homes in FEMA declared flood prone areas of the village.

**RESOLUTION #13,** Established the use rate and rental rates for the Village of Boston Heights pool, park fields and pavilion for 2009.

**RESOLUTION #14,** Authorizing the Mayor to amend and add to the original agreement with Crown Castle GT Company LLC to modify cell tower lease terms.

**RESOLUTION #15,** Appointed resident Ron Dick to the Board of Review of the Income Tax Code.

**A MOTION**, Approved the Village Financial Statement for the month February 2009.

**A MOTION**, allowed for the buy back of Grave #8, Lot 291, Deed #81 in Fairview Cemetery from Isa Freebourne at the original purchase price of \$60.00.

## **COMMITTEE REPORTS:**

Slane - Cemetery Trustees and Association to work one Saturday a month in the cemetery to fill low spots and repair bare areas with grass seed and straw.

Cheung - reported that the Comprehensive Plan Committee would meet April 22. The Board of Zoning Appeals approved a sales sign size increase for an East Hines Hill Road property.

Foss - Reported that the Park Board has acquired eight new umbrellas for the pool.

Miller - has a Safety 11 (Fire) Meeting scheduled for Tuesday, April 21st at 7 PM.

## From the Mayor's Office

Your Solicitor, Clerk-Treasurer and I have been attending meetings concerning a proposed Storm Water Utility Fee which the Northeast Ohio Regional Sewer District [NEORSD] wishes to start collecting to solve NE Ohio storm water issues. Summit County communities linked to the NEORSD could be forced to become part of this program. We need a better definition of benefit to the Village before supporting this program.

Please contact 14<sup>th</sup> District Congressman Steven LaTourette's Office to voice support for funding of the Akron-Cleveland Road Bridge Project. Cost estimate for replacement is over \$4 million, whereas, the Village total yearly operating budget is \$1.3 million. I will be meeting with him in Washington DC on May 15<sup>th</sup>.
