Village of Boston Heights former Mayor, Firefighter and most recently Councilman, Raymond McFall passed away Friday, March 12, 2010. Former Solicitor and present Summit County Executive Russ Pry commemorated Ray in the Beacon Journal with this "Letter to the Editor":

Good man, good mayor

On March 12, Summit County lost a great individual who understood giving back to his community. For over 50 years, Raymond McFall made a difference in the Village of Boston Heights as mayor, volunteer firefighter and council member.

I had the privilege to serve as the village solicitor for 10 years during the time Mr. McFall served as mayor.

Mr. McFall was dedicated, hard-working and always tried to do what he thought was best for the residents of his community. For those of us who knew him, you know that he was not pretentious in any manner. He said what was on his mind.

Mr. McFall was tough, honest and fair as the mayor of Boston Heights. He was a great family man and a great friend to many.

I know how much his wonderful wife, Norma, will miss him. I am thankful for having had the opportunity to work for, and know, Raymond McFall.

He certainly was an example of a good community servant.

Russell M. Pry Summit County Executive Akron Council advertised to fill Ray McFall's seat in the local papers, posting places and on the Boston Heights Overlook website. Two residents [Ron Fenn & Jim Mizanin] applied and on April 8, 2010 at a special council meeting, Ron Fenn was named to fill the remainder of Ray McFall's term.
