Life at the Water's Edge

All of us live in a "Watershed" and we all live upstream or downstream from someone. Water either at ground level or below ground drains to a stream or body of water.

In Summit County, the two major watersheds are the Cuyahoga (River) flows North to Lake Erie and then to the Atlantic Ocean and the Tuscarawas (River) flowing south to the Mississippi River and then the Gulf of Mexico. The division point is just South of Akron in the Portage Lakes area.

In Boston Heights, all of our runoff water ends up in the Cuyahoga River watershed, which is also fed locally by the Brandywine Creek. The quality of the Cuyahoga is controlled by all the areas from which runoff originates so every one of us contribute to its water quality. Controlling your property runoff by using healthy landscape practices, installing raingardens & rainbarrels and planting native plants helps to filter and slow runoff water. All of us benefit from using best practices.

Village Departments

Fire

Paid hourly staffing of the fire department on weekends began in the month of June.

The fire station addition continues to be reviewed by the Council committee and a proposal for a qualified fire station designer is being prepared for bid.

Macedonia EMS continues to be our village's EMS responder for all EMS calls, 24 hours a day, 7 days a week.

Police

Summer is a time many residents leave home for vacations. Chief Varga recommends filling out a Home Check Report at Village Hall so that patrol officers may watch your home anytime you are away for an extended period of time.

Unlocked cars and unsecured structures make it easy for thieves to acquire your property. Always lock doors when leaving a vehicle or dwelling unattended.

Roads

Residents may have branches chipped from storm damage or routine maintenance of your yard by calling Village Hall 330-650-4111 and having your name & address placed on the list.

Branches to be chipped should be stacked in one direction close to the road. Make smaller piles instead of a large one.

Village Engineer

The Village Engineer reviewed drainage and driveway pipe issues, proposed proper solutions and forwarded the list of repairs needed to the Road Superintendent to schedule and perform the needed work. Residents should fill out right-of-way forms and leave them with the clerk at village hall. Projects will be dealt with in the order that they are submitted.

Zoning Inspector

New structures and existing building additions require the zoning inspector to review the project after you fill out an application from Village Hall. That approved form then is taken to the Summit County Building Department and they perform building inspections of approve projects. Our zoning inspector may be contacted through village hall at 330-650-4111.

Deteriorating structures need to be repaired for your safety and to protect your neighbor's property values. Summit County has support programs available to help landowners repair and upkeep their properties if you qualify. Please contact the Zoning Inspector for more information regarding these programs.

Village legislation prohibits unlicensed vehicles from being stored in your yard. Storage of unlicensed vehicles is allowed in garages or other appropriate structures. Please comply with our rules so that all residents are impacted equally.

Village Resident Information

Residents of West Boston Mills Road and "The Ledges" should have been notified by Dominion East Ohio of pipeline replacement work that involves road crossings in you areas. Traffic is to be maintained on Boston Mills and residents in "The Ledges" may need to use the exit open on either side of the road crossing for their access.
