VILLAGE RESIDENT INFORMATION

The Rt. 8 Project nears completion for 2010. Final work is being completed on the southbound on ramp to Rt.8 from Boston Mills and off ramp from the turnpike to Boston Mills Road. These ramps, the northbound off ramp to Boston Mills Road and the Boston Mills Bridge over Rt. 8 are scheduled to open Nov. 12, weather permitting. The northbound ramp from Hines Hill Road to Rt. 8 north opened October 30, 2010.

Completion date for all work is June of 2011. All roadways and ramps are scheduled to be operational by November 12. Final paving of surfaces, painting of bridges, landscaping and other contract items are to be finished in the Spring of 2011.

Traffic backups on Olde Eight at Rt. 303 will be reduced by the Rt. 8 openings, ODOT feels. Other remedies in conjunction with ODOT will be reviewed if the backups continue.

Please call village hall at 330-650-4111 to be placed on the list for fall leaf pickup and branch pickup. The road department will receive your information and if weather permits, they will process your requests.

As snow season begins, remember not to park on roadways or in the right-of-way to allow snowplow drivers to complete their work of clearing snow.

To all vehicle owners in Boston Heights: Remember when you are renewing your license plates and operator's license to use "7703" as your Taxing District. Unless you clearly specify that you live in Boston Heights, funds that the village uses for maintaining your roadways may be directed to other communities. Changes to correct this information must be made at you local BMV.

R.I.T.A. [Regional Income Tax Agency] collects the village's income tax. Each year, you or your tax representative must file with R.I.T.A., whether you owe taxes or not. Smoke and CO [carbon monoxide] detectors should have batteries replaced on a timely basis [such as once a year] for you and your family's protection.

Heating season is here and care should be taken in providing proper clearances for combustibles from furnaces and other heat sources.
