Dear Mayor Goncy:

The excavation work at the Krejci Dump Site is drawing to a close. At this time there remains only one unit of the project on which we are awaiting test results to determine whether all contaminated soils have been removed. We are anticipating that the contractor will be proceeding with the final grading of the site later this year with the re-vegetation work possibly beginning this fall and continuing into the spring of 2012. Barring any unexpected circumstances we feel that the Village of Boston Heights can proceed with planning for the rehabilitation work on Hines Hill Road to begin sometime in the spring of 2012. Since there is still a good possibility that the re-vegetation work at the Krejci Dump Site will spill into that same time period we ask that these activities be coordinated so that both projects might have the best chance of proceeding without interruption.

We appreciate the patience that the Village of Boston Heights has shown through this major cleanup effort and we join you in looking forward to the final completion on this project. VILLAGE UPDATE INFORMATION

* The Route 8 Project, Phase II, was completed October 12, 2011, declared ODOT officials.

Boston Mills Road from Olde Eight to the Hudson Corporation line was repaired and resurfaced and Olde Eight Road saw roadway repairs within the scope of Phase II of the project. A request made by the mayor in a letter to ODOT officials saw these repairs completed at no cost to the village.

- * The Akron-Cleveland Road bridge over the Bike & Hike Trail is moving towards the engineering design stage. Residents using West Hines Hill Road finally have good news concerning the Krejci cleanup project.
- * Cuyahoga Valley National Park [CVNP] officials have sent a letter to the village saying that the final soil removals are to be complete this year. Monies set aside by CVNP for help with roadway repairs will be available in 2012.
- * A landslide along Route 303 just west of the Happy Days building has been repaired by use of soil nails at no cost to the village. An application by the mayor through cooperation with local ODOT officials allowed for this project to proceed with an approval of your village council.
- * Recently completed waterproofing of village hall now allows required records to be kept without damage.
- * An addition to each end of the fire station is underway with completion date sometime in 2012. Firefighters have retained access. Funding for this addition came from fire department capital levies (\$307,850.00 for construction and \$48,400 architectural services) and \$100,000 from a reserve account within the general fund.
- * To all vehicle owners in Boston Heights: Remember when you are renewing your license plates and operator's license to use "7703" as your Taxing District. If the number is not "7703", please go to the BMV to change it so that Boston Heights will be receiving the funds.
- * R.I.T.A. [Regional Income Tax Agency] collects the village's income tax. Each year, you or your tax representative must file with R.I.T.A., whether you owe taxes or not. If you have questions about income tax, you may contact R.I.T.A directly. The toll free number you should use is: 1-800-860-RITA.
- * Smoke and C02 [carbon monoxide] detectors should have batteries replaced on a timely basis [such as once a year] for you and your family's protection.
- * Please welcome to Boston Heights the "PAYCHEX" facility at 100 East Hines Hill Road.
