Fellow Residents,

This upcoming spring, the Cuyahoga Valley National Park will release reserve funds that will enable the village to begin the road repairs on West Hines Hill Road. The village is committed to doing the road repairs with these funds. The timing of the Hines Hill Road project creates an opportunity to gain additional grant funds for a possible bikeway.

The Comprehensive Zoning Plan Committee surveyed village residents in 2009. Of the highest ranking responses, a bike trail and a bike lane ranked second and third as the most desired items to make Boston Heights a more ideal community in which to live.

In response to resident desire, the Village Council has established a memorandum of understanding with Metro Parks of Summit County and the City of Hudson Park Board to explore bikeways. In 2001, Metro Parks established a greenway plan for Summit County. This plan identified ideal locations for bikeways, and those included Hines Hill Road. In November of this year, a matching grant was awarded to conduct a feasibility study for a bikeway along Hines Hill Road.

A public information meeting is scheduled for 7 p.m., January 9, 2012 at Boston Heights Village Hall.

The purpose of the meeting is to inform residents about a potential bikeway on Hines Hill Road. Public input is needed to help determine the feasibility of this potential project.

This bikeway would connect the Metro Parks Bike & Hike Trail to downtown Hudson.

Some facts to consider:

- Bike path construction can also address storm water runoff issues.
- In residential areas, bike paths can be built along a road using the right of way, without needing to use private property.
- Metro Parks is building a new 250 acre park in Hudson on Hines Hill, north of the YDC property. This park will also be a connector to current Hudson Park paths.
- The Hines Hill bridge over Route 8 was constructed with bike path space.
- Grant monies are available to help finance this project.
