A RESOLUTION GIVING CONSENT TO THE STATE OF OHIO TO DO REPAIRS TO THE SLIDE ON SR303 WITHIN THE VILLAGE OF BOSTON HEIGHTS AND DECLARING AN EMERGENCY

WHEREAS, the State has identified the need for project POR/SUM-IR480/SR303 Slide, PID No. 91440 hereinafter known as the repair of slide on SR303 within the Village limits and:

NOW THEREFORE, be it ordained by Council of the Village of Boston Heights, Summit County, Ohio:

<u>SECTION 1:</u> Being in the public interest, the Village of Boston Heights gives consent to the director of Transportation to complete the above described project.

SECTION 2: The Village of Boston Heights shall cooperate with the Director of Transportation in the above described project and agrees to participate in the cost of construction within the Village limits only for work performed after November 16, 2011. The Village agrees to pay twenty percent (20%) for the work performed after said date, which funds will represent the twenty percent (20%) Federal matching requirement.

SECTION 3: The Village of Boston Heights further agrees to pay one hundred percent (100%) of the cost of those features requested by the Village which are determined by the State and Federal Highway Administration to be unnecessary for the Project.

<u>SECTION 4:</u> Upon completion of the described Project, and unless otherwise agreed, the Village shall:

- Provide adequate maintenance for the described Project in accordance with all applicable state and federal law, including, but not limited to 23 USC 116
- 2. Provide ample financial provisions, as necessary, for the maintenance of the described Project
- 3. Maintain the right-of-way, keeping it free of obstructions
- 4. Hold said right-of way inviolate for public highway purposes.

SECTION 5: The Mayor of said Village of Boston Heights is hereby empowered on behalf of the Council of the Village of Boston Heights to enter into contract with ODOT prequalified consultants for the preliminary engineering phase of the Project and to enter into contracts with the director of Transportation necessary to complete the above described project.

Upon the request of ODOT, the Mayor is also empowered to assign all rights, title, and interests of the Village of Boston Heights to ODOT arising from any agreement with its consultant in order to allow ODOT to direct additional or corrective work, recover damages due to errors or omissions, and to exercise all other contractual rights and remedies afforded by law or equity.

The Village of Boston Heights agrees that if Federal Funds are used to pay the cost of any consultant contract, the Village of Boston Heights shall comply with 23 CFR 172 in the selection of its consultant and the administration of the consultant contract. Further the Village of Boston Heights agrees to incorporate ODOT's "Specifications for Consulting Services" as a contract document in all of its consultant contracts. The LPA agrees to require as a scope of services clause, that all plans prepared by the consultant contracts. The Village of Boston Heights agrees to require, a scope of services clause, that all plans prepared by the consultant must conform to ODOT's current design standards and that the consultant shall be responsible for ongoing consultant involvement during the construction phase of the Project. The Village of Boston Heights agrees to include a completion schedule acceptable to ODOT and to assist ODOT in rating the consultant's performance through ODOT's Consultant Evaluation System.

SECTION 6: This Resolution is hereby declared to be an emergency measure to expedite the highway project(s) and to promote highway safety. Following appropriate legislative action, it shall take effect and be in force immediately upon its passage and approval, otherwise it shall take effect and be in force from and after the earliest period allowed by law.

SECTION 7: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
