AN ORDINANCE AMENDING TITLE THREE -LEGISLATIVE, CHAPTER 121 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF BOSTON HEIGHTS AND DECLARING AN EMERGENCY

WHEREAS, the Council has determined to amend the provisions of Title Three -Legislative, Chapter 121 of the Codified Ordinances of the Village of Boston Heights.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Boston Heights, County of Summit and State of Ohio:

<u>Section 1:</u> That Chapter 121, Section 121.02(c)(1) Standing Committees shall be amended and to provide as follows:

121.02 STANDING COMMITTEES

- (1) The Standing Committees of Council are:
 - A. Financial Committee
 - B. Road Committee
 - C. Safety Committee (Police & Fire)
 - D. Lands and Buildings
 - E. Cemetery Committee
 - F. Planning and Zoning Committee
 - G. Economic Development Committee (EDC)

Section 2: That any reference to either the "Safety One Committee" or the "Safety Two Committee" within the Codified Ordinances of the Village of Boston Heights shall hereby be amended and replaced with the singular reference to the "Safety Committee"

<u>Section 3:</u> That all other provisions of Chapter 121 not specifically amended herein shall remain in full force and effect.

<u>Section 4:</u> That this Ordinance is hereby declared an emergency measure necessary for the preservation of the public peace, and safety of the residents of the Village of Boston Heights and to insure orderly operations of Village all functions through the standing Committees and shall take effect immediately upon its passage.

Section 5: That this Council hereby finds and determines that all formal actions relative to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements including Section 121.22 of the Ohio Revised Code.
