## **OPEN FORUM**

Ohio House Representative Bill Roemer made a few remarks in appreciation of outgoing Mayor Bill Goncy's long and dedicated service to the Village, and noting the many positive changes in the Village due to his efforts. After a round of applause, Mr. Goncy made a few remarks in that same vein.

Mr. Roemer then administered the oath of office to Mayor-Elect Ron Antal, whose term begins January 1, 2024. Mr. Antal then made some appreciative remarks concerning Mr. Goncy, as well.

Mr. Antal, who is presently President Pro Tempore of Council, then administered the oath to both incoming Council members: David Maccarone and Richard Lyon. Mr. Maccarone had previously been filling a vacated Council seat by appointment. (Note that Mr. Antal's seat on Council will then become vacant in January.)

Mr. Antal presented Mayor Goncy with a plaque and proclamation of thanks from Village Council. The Fairview Cemetery Association did likewise.

This was all followed by an interlude for cake and refreshments.

### APPROVAL OF MINUTES

Minutes of the November 14th and November 28th 2023 meetings were approved and adopted.

## **ORDINANCES**

ORDINANCE 2023-12-24 (First Reading)

ADOPTED Ord 2023-12-24 AN ORDINANCE BY THE COUNCIL OF THE VILLAGE OF BOSTON HEIGHTS IMPOSING A MORATORIUM FOR A PERIOD OF ONE YEAR (365 DAYS) ON THE GRANTING OF ANY PERMITS FOR ALLOWING RETAIL DISPENSERIES, CULTIVATORS, OR PROCESSORS OF MEDICAL AND RECREATIONAL MARIJUANA WITHIN THE VILLAGE OF BOSTON HEIGHTS, AND DECLARING AN EMERGENCY.

Ed. Note: This is in reference to the recently-passed Issue 2 initiative to legalize recreational marijuana in Ohio. Mr. Fenn reported that Solicitor Marshal Pitchford had determined that such a moratorium was legal. Ms. Vadas noted that the Ohio legislature was still debating proposed changes to the Issue 2 law and so rules and regulations were still in flux.

ORDINANCE 2023-12-25 (First Reading)

To 2nd Reading

AN ORDINANCE AMENDING SECTION 121.02(d)(1) AND CREATING SECTIONS 121.02(d)(7) and 121.02(e)(6) OF THE CODIFIED ORDINANCES, A PART OF THE RULES OF COUNCIL; AND DECLARING AN EMERGENCY.

Ed. Note: This is in reference to the Solicitor's stated intention to tighten up some of the rules for Council meetings, specifically the means for canceling them. Mr. Fenn suggested that further discussion was in order, primarily because the notion of adjournment to a definite date had not been discussed. The matter was left to a second reading.

ORDINANCE 2023-12-26 (First Reading)

ADOPTED Ord 2023-12-26 AN ORDINANCE AMENDING CODIFIED ORDINANCE CHAPTER 189 TO ADOPT UPDATES AND TO CONFORM TO OHIO AMENDED SUBSTITUTE HOUSE BILL 33; AND DECLARING AN EMERGENCY.

Ed. Note: This chapter established the Village's income tax. The Fiscal Officer explained that this measure aligns the Village with the new state regulations on net profits taxation and Work From Home tax allocation. Mayor Goncy noted also that Summit County's inter-community income tax sharing (anti-poaching) agreement was in the process of revision.
